- ~ In the 4-H classes, Exhibitors enrolled in a 4-H Horse Project show their own project horse(s) & compete at their current 4-H riding level
 - ~ There will be Boulder County 4-H HLC High Points awarded toward year end high point award for classes marked with (**).
 - ~ **Helmets are REQUIRED for all Walk/Trot thru Level I Riders & recommended for all others. Helmets required for gymkhana events.**
 - ~ The Equitation/Horsemanship classes will be a pattern for level I and above and no rail work unless requested by Judge.
 - ~ Management may elect to combine classes with 3 or fewer entries or split classes with a lot of entries.
 - ~ No Stalls available, but you may utilize Barn C or tie at your trailer. **Please clean up after your horse-hay/manure.**
 - ~ Age as of December 31, 2018 ~ Proceeds from this show will benefit Boulder County 4-H Youth Horse Program
 - ~ Riders in walk/trot/jog classes may not enter any class that canters/lopes at this show ~ 4-H members showing in 4-H classes must show their project horse in their correct level class
- NO REFUNDS ON SCRATCHES - NO STALLIONS OR DOGS ALLOWED - 4-H SAFETY RULES WILL BE ENFORCED**
